



## Liability Release

My assumption of the entire risk of any and all losses to me in the Event is intended to apply to any and all losses no matter how the loss (or losses) is (or are) caused. My assumption of the entire risk of any and all losses to me in the Event is intended to cover any loss or losses caused by a negligent act or a negligent failure to act. I release and discharge the Southern Traverse (2005) Ltd, the Southern Traverse organisation and all persons and entities connected with the Event from any and all claims that arise as the result of loss, property damage, injury, illness or death to me in the Event. Note: only New Zealand laws apply.
