How to Enter:

Complete this entry form and return with entry fee to: **Southern Traverse Ltd P.O. Box 410, Queenstown.**

For competitors aged under 18 the form must be signed by a parent or guardian.

Alternatively, enter on-line and pay by credit card - go to www.tourdewakatipu.co.nz.

Entry fee: \$75 per person, Junior (19 years and under) \$45. For all entries, \$5 go to Cure Kids.

Family pass (2 adults, 2 children under 14yrs old) \$200. Only available on downloadable entry form, and subject to conditions.

Note that once entered, all communication will be done by email. Ensure we have your current and clearly marked email address.



Divisions:

Recreational: for racers who wish to have a good fun ride. 36kms total

Sport: For racers who wish for more of a challenge. 45kms total, including Lake Hayes loop.

Elite: For the fast and furious, 45kms total including Lake Hayes loop.

Registration / Race Briefing:

Located at Millbrook Resort, registration will take place on race day Saturday 7th April 2012 from 7am to 8am for Elite and Sport, and from 8am to 9am for Recreational competitors. These times are provisional only.

Race briefings: 8.15am for Elite, Sport. 9.30am for Recreational (times subject to change).

Start times: From 8am for Elite and Sport, From 10am for Recreational (times subject to change).
